

## California Household Cleaning Product Right to Know Act 2017 State of California SB-258 Disclosure Statement

#### **Section 108954.5 (5)**

Electronic links for Designated lists shall be grouped together in a single location for an intentionally added ingredient or nonfunctional constituent that is included on a designated list and any fragrance allergen included on Annex III of the EU Cosmetics Regulation No. 1223/2009 as required to be labeled by the EU Detergents Regulation No. 648/2004, or subsequent updates to those regulations.
